Equipment students need to bring (Packing List)

- Lunch and Water bottle(s), in a small day pack or backpack for Bushwalking, Mountain biking and day activities
- Large overnight bag enough clothing for 3 days of activities.
- School sports uniform for Wednesday
- Weather/activity appropriate clothing, SLEEVED SHIRTS required
- Clothing for Canoeing board shorts, t-shirt, a weatherproof jacket and old shoes/ reef shoes
- Enclosed footwear at all times (THONGS/ SLIDES can be worn inside the bunkhouse)
- A towel, toiletries and a plastic bag for wet clothing
- Torch
- Crockery and Cutlery a reusable plate, cutlery and thermal cup/mug are required. This will help reduce the
 use of plastic and disposable products
- Sleeping bag and appropriate sleeping equipment (Pillow, rug etc). The sleeping venue is a Bunkhouse that is self-contained. *Please see Miss Lynch for any further information*
- It is recommended students bring their mobile phones as a means of communication while bushwalking and Mountain bike riding. However, the use of any personal devices on camp is aligned with the school's mobile phone policy. The school accepts no responsibility of any lost, damaged or stolen personal items
- Personal medical equipment or medication. Staff must be informed of these items and aware of any monitoring or administration required (please list on medical form attached)

Equipment the school provides

- Meals from Wednesday evening to Friday Lunch
- Transportation for large overnight bag and for students between venues
- Extra water
- Dish washing equipment
- First aid kit general first aid equipment only
- Canoes and Mountain biking equipment
